Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
- 2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Food Management and Trading Company Limited, Bhadrakali Plaza, Kathmandu, Nepal or may visit PPMO egp system www.bolpatra.gov.np/egp.
- 3. A complete set of Bidding Documents may be purchased from the office Food Management and Trading Company Limited, Bhadrakali Plaza, Kathmandu, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 25,000/- till 10 November 2023 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following account as specified below .

- 4. Pre-bid meeting shall be held at Food Management and Trading Company Limited, Bhadrakali Plaza, Kathmandu, Nepal at October 27, 2023
- 5. Sealed or Electronic bids must be submitted to the office Food Management and Trading Company Limited(FMTCL), Bhadrakali Plaza,Kathmandu,Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 13:00 hr on November 17, 2023. Bids or any parts received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hr., November 17, 2023 at the office of Food Management and Trading Company Limited, Bhadrakali Plaza, Kathmandu, Nepal. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of US\$. 1,38,000/- which shall be valid for 30 days beyond the validity period of the bid (i.e. April 14, 2024)
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
