- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 02:00 PM on B.S. 2081/03/20 at the Head office of Food Management and Trading Company Ltd, Bhadrakali Plaza, Kathmandu.

Bid must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **66,500/-** which shall be valid for 30 days beyond the validity period of the bid.
