1. **Food Management and Trading Company Limited** invites electronic bids from eligible bidders for the construction of Construction , supplying and Installation of 300 kg per hour semi Automatic flattened rice (Normal and Crunchy) Plant at Hetuda Makwanpur for under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
2. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: In NRs. 5,91,42,000.0/-
 - Minimum Work experience of similar size and nature: **Construction , supplying and installation of Food processing plant Minimum-1 No of project and Value in Nrs. 1,97,14,000.0/-**
3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

6. Pre-bid meeting shall be held at **Food Management and Trading Company Limited Head office, Kathmandu, Procurement Department** at 2082-12-06, 2:00 PM
7. Electronic bids must be submitted to the office Food Management And Trading Company Limited Bhadrakali plaza only through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2082/12/17. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00PM on 2082-12-17 at the office of **Food Management and Trading Company Limited Head office Kathmandu, Procurement Department**. Bids must be valid for a period of 120 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs.13,55,000/- which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
