1. The *Food Management and Trading Company Limited* invites *electronic* bids from eligible bidders for the procurement of *Supplying and Installations of Indigenous Crop Processing and Package Facility at Nakhu, Lalitpur* under National competitive bidding – Single Stage Two Envelope procedures.

The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/ cross discounts. Evaluation will be done for each package/lot, with contracts awarded based on the award combination that is of least cost to the Purchaser.]

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of *Food Management and Trading Company Limited, Bhadrakaliplaza Kathmandu Procurement Department* or may visit PPMO eGP system www.bolpatra.gov.np/egp.
3. Bidder must submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Nrs.10000.00 in the following Rajaswa (revenue) account as specified below.

5. electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2082-12-17 12.00 Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2082-12-17 13.00 at the office of Food Management and Trading Company Limited , Bhadrakaliplaza, Kathmandu Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,

amounting to a minimum of NRs. 578000.00 which shall be valid for 30 days beyond the validity period of the bid

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
