Sealed Quotations shall be opened in the presence of Bidders' representatives who choose to attend at 11-04-2025 14:00 hours at the office of Food Management and Trading Company Ltd, Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs.50000 which shall be valid for 30 days beyond the validity period of the bid i.e 75 days.
