5. Sealed or Electronic bids must be submitted to the office *Food Management And Trading Company* through PPMO website www.bolpatra.gov.np/egp on before on *2083/01/09, 12:00 AM* Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at *2:00 PM,2083-01-09 (2026-04-22)* at the office of *Food Management And Trading Company Limited Procurement Division Head office Kathmandu*. Bids must be valid for a period of *90 days* from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of *Nrs.4,87,000/-* which shall be valid for 30 days beyond the validity period of the bid.
