The bids will be opened in the presence of Bidders' representatives who choose to attend at 18-04-2025 14:00 at the office of Food Management and Trading Company Limited , Head Office , Bhadrakali Plaza Kathamndu Purchage Unit / Department . Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 73500.0, which shall be valid for 30 days beyond the validity period of the bid.
